Here are the details for the 2019 Routt County Livestock Judging Contest which will be held on Saturday, May 11 at the Routt County Fairgrounds in Hayden.

REGISTRATION POLICY-

We must receive your entry forms by 5:00 p.m. **Friday, May 3**, so that we are able to provide a meal headcount to the caterer. You can mail them to PO Box 772830, Steamboat Springs, CO 80477, fax them to (970) 870-5383 or e-mail them to jquigley@co.routt.co.us. Please make checks payable to: Routt County 4-H Livestock Judging.

Coaches/agents will need to register how many 4-H/FFA members are planning on attending the 2019 Routt County 4-H Livestock Judging Contest by May 3rd to the Routt County Extension Office along with their registration fee. This will allow us to get a head count for meals. During registration on May 11 from 7:30 am to 8:45 am, coaches will be responsible for submitting the attached team and individual lists to designate their 4 member teams and individuals with the registration crew. If you need to pair individuals with another county or group to field a complete team, this will be done at registration on May 11th. Contestant's cards, numbers and a class list with reasons classes will be given to them at this time. Coaches will be responsible for providing the youth members their cards, contestant numbers and class list. One set of results will be printed and available to each county or FFA Chapter after the awards program.

NOTE: Members need to eat lunch at the contest to keep things running smoothly. Please remember to count adults who are coming, including drivers or assistants that will need to eat as well, or we may not have meal tickets available!

1. Routt County Fairgrounds, Hayden, Colorado
2. Registration 7:30 a.m. - 8:45 a.m. – Exhibit Hall - Routt County Fairgrounds
3. Registration fee of \$20.00/member (NON-REFUNDABLE)
4. Adult Lunch \$6.00/meal (**NON-REFUNDABLE**)
5. Livestock Judging classes (4 beef, 2 sheep, 1 goat, 3 swine) 4 sets of reasons for seniors and 3 sets for juniors; exact number of classes and reasons are tentative and may change.
6. No limit on the number of 4-H/FFA members who may enter (junior - 13 and under as of Jan. 1; senior - 14 and over as of Jan. 1).
7. No limit on number of teams entered. All contestants are eligible for individual awards.
8. Awards presented at the end of the program (approximately 3 p.m.).
9. Only individuals that do not have enough members in their county to field a team can collaborate with another county to complete a team.
10. One set of results will be printed and available to coaches after the contest
11. Adult contest will be available for coaches and adults wanting to participate. Registration will take place the morning of the contest with a registration fee of \$5.00.
