### **Objective**

Each county or area is invited to enter as many teams and/or individuals as the county deems appropriate in the State 4-H Horse Judging, Bowl or Hippology Contest. Further specifics for each year will be available from the State 4-H Office along with registration materials. The team members shall be selected in a manner as determined by the local county (area) or Colorado State University Extension office. The [Colorado 4-H Youth Development Policies](#) (page 6) state that "Youth may join 4-H Youth Development and enroll in projects in only one county at a time." The Colorado 4-H Youth Development Policies further outline conditions under which counties may combine teams (page-9). Counties must combine within defined areas or the county with the closest viable team program. A "Declaration of Intent to Combine" is due to the appropriate CSU 4-H Youth Specialist by April 15 of the current year. It is the philosophy of the Colorado 4-H Program to focus on and support county programs.



## **4-H HORSE BOWL CONTEST**

### **Objectives**

The primary objective of Horse Bowl contests is to provide an opportunity for youth enrolled in 4-H to demonstrate their knowledge of equine-related subject matter in a competitive setting where attitudes of friendliness and fairness prevail.

These contests will provide an educational experience for both participants and spectators.

### **Rules and Regulations for State 4-H Conference**

#### **Contestants and Eligibility**

1. Each county or area is invited to enter as many teams and/or individuals as the county deems appropriate in the State 4-H Horse Judging, Bowl or Hippology Contest. One team member will be designated as alternate if five (5) are entered. Teams may be selected by any procedure which the county deems appropriate.
2. Contestants must be at least 14 years of age (by Dec. 31<sup>st</sup> of current 4-H year) but not yet have reached their 19th birthday (by December 31<sup>st</sup> of current 4-H year). of the current year.
3. Contestants must be enrolled in 4-H in the county or area they represent or combined in accordance with state 4-H policy prior to April 15 of the current year.
4. Contest team entry and eligibility must be certified by the county Colorado State University Extension 4-H office.
5. Teams and individual members of that team, who have competed at the National 4-H Contest (National Western Roundup and Horse Classic), as the official Colorado 4-H representative entry will be allowed to compete as members of teams or as individuals at the state contest and be eligible for prizes/awards. However, the team members/individuals which represented Colorado at the National Western Roundup and Horse Classic are considered to be ineligible to represent Colorado again for the at the National 4-H Contest (National Western Roundup and Horse Classic). Should a team with members who have represented Colorado at the National 4-H Contest win state again or place high enough that the opportunity is passed to them, those members may not participate on the team entered in the National 4-H Contest. Members of the team that have not used their eligibility to compete at the Nation 4-H Contest may compete providing the team entered meets the substitution for national contest policy requirements (see State 4-H Policy Document). In the event the team cannot meet the substitution requirements the opportunity to represent Colorado shall be passed on to the next team that meets the above outlined criteria. Further, teams or individuals who win a state competition in more than one contest area may continue to compete in the contest area(s) in which they did not represent Colorado at the 4-H National Contest. At County Contests it is at the host county's discretion as to how eligibility is handled. The State Champion Team from the State 4-H



Contest is expected and encouraged to represent Colorado 4-H at the National 4-H Contest in January of the following year, in Denver (Western Roundup, if they are eligible) but it is not required. Colorado 4-H members are not eligible to attend the Eastern National Horse contests in Louisville KY. If the State Champion does not choose to compete at the National 4-H Contest, the opportunity will be offered to the second-place team. If the second-place team declines to represent Colorado at the National 4-H Contest, it will then be offered to the third-place team. If the third-place team declines, it will not be offered to any other teams and Colorado will not be represented in that contest. Should the second or third place team choose to accept and go on to represent Colorado State at the National 4-H Contest, the previously outlined ineligibility rules will apply to that team/individuals representing Colorado at the National 4-H Contest for that specific activity.

**Horse Bowl Questions**

There will be four types of questions.

1. One-On-One: The first category of questions will consist of one-on-one questions that will be presented to a specific chair on the two teams. These will be worth 2 points to the player and team to answer it correctly and minus one if answered incorrectly.
2. Toss-Up: The second category is toss-up questions that may be answered by any seated player from either team. The toss-up questions are worth one point for the player and team that answers it correctly and minus one if answered incorrectly.



3. Toss-Up with Bonus: The third category is toss-up with a bonus attached. The scoring will be the same as the toss-up questions but the team answering it correctly will receive a bonus question.
4. Bonus: The fourth category is the bonus question. This will be a multi-part question and the team may have ten seconds to confer prior to answering. All parts of the question must be answered correctly to receive the predetermined points and no parts of the question will be repeated nor will any additional information be given. Only one member of the team will answer, however other team members may feed information to the individual answering. The bonus will be worth 1 to 3 points, depending on the difficulty. Superintendents will determine the point value before the contest begins.

### **Equipment**

1. Game Panels — An appropriate device will be used to provide a clear indication of the first contestant to respond to a question.
2. Time Recorders — A stop watch or other appropriate time device will be required.
3. Signal Device — This signal device shall be used by the time keepers and shall have a very distinctly different sound from that associated with the game panel.
4. Score Keeping Devices — Two devices will be needed: one, such as a blackboard, flip chart or electronic light display, will be used to maintain team scores visible to the contestants and, if possible, to the spectators; a second device will be required to maintain a record of individual contestant scores.

### **Officials**

1. Moderator (Quiz Person) — The moderator shall assume the direction of the matches within that particular room, ask all questions, designate contestants to answer questions and accept or reject all answers unless the questions and/or answers are challenged. The moderator may indicate when a contestant has exceeded the allocated time for a question. The moderator will declare the match winner and shall at all times be in control of the matches.
2. Referee Judges — At least two referee judges are recommended. The judges must be knowledgeable about horses. One referee judge (or the moderator) should, if possible, be a veterinarian. The referee judges rule jointly on the acceptability of any question or answer. In cases of challenge to questions or answers in matches with two referee judges, either both referee judges or one referee judge and the moderator must agree on the acceptability or rejection of any question and/or answer. With only one referee judge, both the judge and the moderator must agree on actions to be taken.
3. Timekeeper — Unless this duty is assumed by the moderator or by a referee judge, the timekeeper will monitor all time intervals and designate when time of response has been exceeded and will handle



all controls of the game equipment. It is strongly recommended that neither the moderator nor a referee judge be used as a timekeeper.

4. Scorekeepers — At least two individuals shall be used to keep score for each contest. The individual maintaining team scores shall do so in such a manner that all points awarded or taken from each team may be checked and the scores are clearly visible to the moderator and to the contestants. The second scorekeeper shall be used to maintain a record of the individual scores of each contestant. An assistant to the scorekeeper maintaining individual records is suggested.

### **Teams**

1. Each team shall consist of not less than three (3) or more than five (5) members.
2. Only four (4) contestants shall be seated at the panel at any one time.
3. During any match, only one (1) team member may be replaced at the panel when:
  - A. the moderator deems it impossible for one of the seated members of the team to continue in the contest, or,
  - B. the captain of a team requests the replacement of a team member.
4. The team member removed from a match becomes ineligible to return to that particular match. The team member removed and the replacement member are both eligible to participate in further matches. The use of a five-member team is strongly recommended.
5. There will be only one coach designated during any given round in respect to disputes of score or question challenges.
6. The coach and alternate of each team shall sit in an area designated by the moderator.
7. Coaches will either travel with their teams between rounds, or stay exclusively in the contest room during the duration of the rounds.

### **Procedures of Play**

1. Match Procedures
  - a. Each match will be divided into two parts based on number of questions (40 questions per round plus 3 bonus questions).
  - b. In the first part of the match, during the one-on-one competition, only one member of each team will be eligible to respond to a question. This eligibility will rotate with each question beginning with the number 1 players on each team, and passing to the number 2, 3 and 4 contestants of each team, respectively, until all the one-on-one questions have been asked. The number of questions asked during the first part of the game should be evenly divisible by 4 to assure each team member an opportunity to respond to the same number of questions (i.e., 20 questions).
  - c. During the second part of the match any individual on either team may respond to a question (20 total questions).



- d. The contestant activating the buzzer shall have five (5) seconds, AFTER HAVING BEEN RECOGNIZED BY THE MODERATOR, to begin the answer to the question. If the buzzer is activated during the reading of any question, the moderator immediately will cease reading the question.
  - e. The moderator will continue reading questions (and bonus questions if applicable) until all questions have been asked.
  - f. If a question is thrown out either due to poor reading by the moderator or a decision of the referee judges, it will be replaced by another question so that the total number of questions to be asked remains consistent.
  - g. Either team captain or coach, or the moderator may call for a "time out" for clarification of a rule, to permit replacement of a team member, or to allow for unexpected problems. These "time outs" may be called only after a question has been answered and before the start of the next question.
2. Starting the Contest
- a. Teams are assembled and seated at their respective panels and each contestant given the opportunity to check the equipment.
  - b. A team captain is designated and is seated at the direction of the moderator in position number one.
  - c. The question packet is opened by the moderator.
  - d. The moderator reads the first question (as with all succeeding questions) until the completion of the reading of the question or until such time as a contestant activates a buzzer. If a buzzer is activated during the reading of any question, the moderator immediately will cease reading the question.
  - e. The contestant activating the buzzer shall have five (5) seconds AFTER HAVING BEEN RECOGNIZED BY THE MODERATOR to begin the answer to the question.
    - i. The repeating of the question by the contestant shall not be considered the initiation of an answer.
    - ii. It shall be the responsibility of the moderator and the referee judges to determine if an actual answer is started within the 5-second period.
  - f. If the answer to a question is incorrect, that team and individual loses one point.



- g. If the answer to any question, whether read to completion or not, is incorrect that same question will be turned over to the other team. If the question was read to completion, it will not be read again. If not read to completion the moderator will reread the question for the other team. If answered correctly the appropriate points will be awarded. If answered incorrectly no penalty points will be imposed.
- h. If a member of a team activates a buzzer and an answer has not been started within the 5-second allowable time, there will be an appropriate 1 point penalty imposed against the team and the contestant activating the buzzer. The question will be turned over to the other team.

### 3. One-on-One Questions

- a. The moderator shall indicate clearly the start of one-on-one play.
- b. Each question shall be addressed to only one member of each team, beginning with the number 1 contestant of each team and progressing with subsequent questions to the number 2, 3 and 4 contestants, respectively.
- c. The moderator shall indicate prior to the reading of each question which two contestants are eligible to respond.
  - i. If any contestant other than the two designated contestants responds, that individual and the team will lose two points.
  - ii. If any contestant responds more than twice to questions directed to another contestant, they shall be replaced at the panel by the alternate if available. If no alternate is available, the remainder of the match will be played with less than the full team, and all questions normally addressed to the eliminated contestant will be addressed only to the opposing contestant.
- d. There will be no bonus questions asked during the one-on-one period.
- e. The point value of a response to a one-on-one question will be as follows:
  - i. Correct response = +2 points (individual and team)
  - ii. Incorrect response = loss of 1 point (individual and team)
  - iii. If both contestants to whom a question is addressed fail to signal an intent to attempt an answer in the 5-second allowed time, neither



contestant nor team shall lose or gain any points. The answer will be given and the next question read.

#### 4. Toss-Up Questions

- a. The moderator shall indicate clearly the start of toss-up questions.
- b. The point value of a response to a toss-up question will be as follows:
  - i. Correct response = +1 point (individual and team)
  - ii. Incorrect response = loss of 1 point (individual and team)
  - iii. If no contestant signals an intent to attempt an answer in the 5-second allowed time, neither contestant nor team shall lose or gain any points. The answer will be given and the next question read.

#### 5. Bonus Questions

- a. The moderator shall indicate clearly that a bonus question is attached to a toss-up question.
- b. A bonus question that is attached to a toss-up question is given to the team whose member has just correctly answered the question.
  - i. If a bonus question was attached to an unanswered toss-up question, the bonus question is then transferred to the next question.
  - ii. If a bonus question is attached to an incorrectly answered toss-up question or to a toss-up question, which was unanswered following the activation of the buzzer, that bonus question is transferred to the next question.
- c. If a bonus question is attached to the correctly answered toss-up question, the moderator then reads the bonus question and a 10-second discussion period is permitted for team consultation to determine the answer. The end of the 10-second period is signaled by the timer. At the signal from the time, a 5-second period is then permitted for the team captain or designee to begin the answer.
- d. All parts of bonus questions must be answered correctly with no partial points permitted, regardless of the number of parts of the question answered correctly.



e. No part of the bonus question will be repeated nor will any additional information be given to the contestants relative to the question.

f. The point value of a response to a bonus question will be as follows:

iii. Correct response = 3 points

1. Does not count toward team participation bonus points

iv. Incorrect response = no points lost

v. No answer = no points lost

#### 6. Team Participation Bonus Points

a. In order to encourage full team participation, bonus points will be awarded in each match to the teams that have each team member correctly respond to a question other than bonus questions. This bonus shall be worth 2 points to either team that qualifies. After having earned this team bonus once within a match, both teams are eligible to earn an additional bonus of 2 points by repeating the process specified for team bonus awards.

i. In order to obtain these bonus points, each member of the team SEATED AT THE TIME must have correctly answered a question. If a team member, already having answered a question correctly, is replaced by an alternate, and that team has not yet earned the bonus points, it will be necessary for the alternate to also answer a question correctly before the bonus points may be awarded.

ii. No team will be credited toward a team bonus with a member's second correct response until the first team bonus has been awarded. Each time Team Bonus points are awarded the team may again begin accumulating credits for Team Bonus points.

iii. Teams with only 3 members are not eligible for team bonuses.

#### 7. Completing the Contest

a. The moderator will continue reading questions (and bonus questions, if applicable) until all questions have been asked.



- b. If a question is thrown out either due to poor reading by the moderator or a decision of the referee judges, it will be replaced by another question so that the total number of questions to be asked remains constant.
  - c. Following the final question, the team with the highest number of points shall be declared the winner of that match.
  - d. In the event of a tie after the designated number of questions, five additional toss-up questions will be asked. Bonus questions will not be asked in the overtime period. If a tie still remains after the overtime, additional questions will be asked and the first team to win a point (or because of a loss of a point by the other team, has a 1-point advantage) will be declared the winner. Tie breaker points do NOT get added to individual, team or team bonus scores. They are used to break match ties only.
  - e. Once the moderator has declared a winner based on the scores, there shall be no protest.
  - f. There shall be no protest of any questions or answers following the declaration of the winner.
8. Protests of Questions and/or Answers
- a. A protest of a question or answer to a question may be made only by the team captain or coach of either team and then only at the time a particular question is read or the answer is given. The moderator and the referee judges will consider the protest, and their decision in all cases is final. A protest must be made before the next question is read.
  - b. When a protest is made, play will be suspended until the protest is resolved.
    - i. The protesting team will be given 3 minutes to support their protest.
    - ii. Reference material will be available in the contest room for their use.
    - iii. A 1-point penalty will be assessed if the protest is not upheld.
  - c. If a protest is sustained, the moderator will take one of the following actions as is deemed appropriate:
    - i. A question is protested before an answer is given and the protest sustained — discard the question. A substitute question will be read.
    - ii. An answer is protested (either correct or incorrect) — at least one of the referee judges and the moderator or both referee judges determine the validity of the protest. Points will be added or subtracted as appropriate.



- iii. A question is protested after an answer is given (correct or incorrect) — at least one referee judge and the moderator or both referee judges determine the validity of the protest of the question. The question may then be discarded at no loss of points and a substitute question will be read, or the question may be allowed with the appropriate gain or loss of points as in (Cii) above.
  - d. Abuse of protest provisions may result in one or more of the following:
    - i. Dismissal of team coach from the contest area.
    - ii. Dismissal (or replacement) of team captain.
    - iii. Dismissal of entire team with forfeiture of any points or standing.
  - e. Spectators, parents and visitors may not protest any question, answer or procedure during the course of play. They may, however, submit in writing to the contest officials any suggestions, complaints or protests at the conclusion of the contest. Unseemly behavior, unsportsmanlike conduct or any actions, which are generally accepted as detrimental to the contest, may subject the perpetrators of such actions to dismissal from the immediate area of the contest.
  - f. No source of information is infallible. There may at times be answers given to questions which are in agreement with the recommended sources which are in fact erroneous or out of date. Every effort shall be made to eliminate such questions, but in the event of such occurrence, the referee judges and moderator may agree to:
    - i. To accept the answer and give an explanation of the correct or updated information for future use of the question.
    - ii. Replace the question to the appropriate contestants
    - iii. To accept only the correct answer.
    - iv. In an instance where there is a conflict of information between sources, the most recent source (publication date) will prevail.
9. Recorders, Cameras, and Communication Devices
- a. Tape recorders may not be used at any time during the conduct of a match.
  - b. No recording devices such as videotape cameras, movie cameras or any other type of may be used during the conduct of a match.
  - c. Photographs will be permitted only before and after a match and then in only such a manner as not to be disruptive of the contest.
  - d. Cell phones, tablets, and all other communication devices are to be turned off while in the contest room.



- e. Transcribing contest questions by any means is prohibited. There will be NO handwriting, typing, recording or computer use in the contest rooms. Affiliated teams will be eliminated from the competition for violation of this rule.

**Scoring**

- 1. One-on-One Questions
  - a. Correct.....+ 2 individual & team
  - b. Incorrect..... - 1 individual & team
  - c. A contestant other than the two designated contestants responds..... - 2 individual & team
- 2. Toss-Up Questions
  - a. Correct..... + 1 individual & team
  - b. Incorrect .....- 1 individual & team
- 3. Bonus Questions
  - a. Correct..... + 3 team
  - b. Incorrect.....No points lost
- 4. Miscellaneous
  - a. Fail to signal or contestant not acknowledged by moderator..... - 1 individual & team
  - b. Fail to answer after signaling intent to answer is an incorrect answer.
- 5. Team Bonus Points
  - a. Every time each seated member of a team has correctly answered at least one question, that team gets +2 points. No answers will accumulate toward a second team bonus for that team until the first team bonus has been awarded.
- 6. Protesting
  - a. Not upheld..... - 1 team point
  - b. Upheld..... No penalty points lost
  - c. Abused..... Dismissal of team and loss of all points

**Awards**

- 1. Team Awards
  - a. Team awards will be based on a predetermined procedure of play.
    - i. The exact procedure to be followed must be determined by the number of teams participating and the time allocated for the contest.



- ii. Insofar as possible, double elimination brackets will be used.
  - iii. Insofar as possible, every team will have an opportunity to participate in a minimum of two matches.
- b. The rank of teams will be determined on the basis of their position within the double elimination brackets.
- i. To place teams eliminated in the same round, the losing team which has the most points will be awarded the higher rank.
  - ii. Ties for team awards will be broken on the basis of: First, high average score for the entire contest; second, highest match score; third, total score of the two matches. If a tie remains after all three tie breakers have been executed, a coin toss will be the final determining tiebreaker.
2. Individual Awards
- a. Scores will be kept for each individual contestant, with the high 10 individual contestants to receive special recognition. However, only the top five will be announced at the awards program; others will be listed.
  - b. All contestants who have participated will be considered for the top individual awards.
    - i. The three high match scores for each individual will be used in cases where individuals participate in more than three matches.
    - ii. Ties for individual awards will be broken on the basis of: first, high average score for the entire contest; second, high individual round scores; and third, total number of points earned in the contest. If a tie remains after all three tie breakers have been executed, a coin toss will be the final determining tiebreaker.

### **Equipment Failure**

- 1. It shall be the responsibility of each contestant to assure themselves that all equipment is operating correctly at the start of the match.
- 2. Failure During a Match
  - a. If the device being used ceases to function during a match or is believed to be malfunctioning, a “time-out” may be called by any contestant, the moderator or by either coach.
  - b. If after checking it is determined that there is an equipment malfunction, the faulty part(s) will be replaced and play resumed.



- c. Scores accumulated up to the point of the “time-out” shall stand and all further points awarded during the remainder of the match added to or subtracted from this total.
  - i. If both referee judges or one referee judge and the moderator deem it advisable, points awarded for the two (2) questions asked immediately prior to determination of equipment failure may be recalled and two (2) additional questions used.
- d. Under no conditions shall there be a replay of a match in which there was equipment failure.

**Protocol for Teams to Compete in National Contests:**

**Competing in National Contests**

The state champion from the State 4-H Contest is expected to represent Colorado 4-H at the National 4-H Contest in January of the following year, in Denver (Western Roundup). Colorado 4-H members are not eligible to attend the Eastern National horse contests in Louisville, KY. However, the high team/individual (if it is an individual contest such as speech or demo from here on noted as “individual”) may select two additional national contests such as contests held by various breed associations. Please contact the contest organizers for further details and entry limitations. This team/individual must designate the two contests they have chosen by July 1<sup>st</sup> of the year they win the state contest. The coach of the winning team/individual is responsible for notifying the coach of the second-place team/individual, the State 4-H Equine Extension Specialist and the State 4-H Contest Superintendent of their choices by **July 1<sup>st</sup>**.

The reserve state champion from the State 4-H Contest may represent Colorado 4-H at two national contests, after the state champions have made their selection. The coach of the second-place team/individual is responsible for notifying the coach of the third-place team/individual, the State 4-H Equine Extension Specialist and the State 4-H Contest Superintendent of their contest choices by **July 10<sup>th</sup>**.

The third high team/individual from the state contest may represent Colorado 4-H at one national contest after being notified of the intentions of the state champions and reserve champions.

4-H coaches are welcome to take their teams/individuals to any national contest where there is no limit imposed by the contest on the entry of 4-H teams by each state. In any contest where the entries of 4-H teams are limited, the above protocol regarding eligibility must be followed. Only when a contest has not been selected by the first three placing senior teams/individuals at the state contest, may unranked teams be entered to represent counties in the Colorado 4-H program.

When considering out-of-state travel with junior 4-H members, please check with your county Extension Specialist on county and state policies. Generally, juniors do not go on national trips, unless there is a case where a junior is used to fill a senior team, i.e. no other seniors from that county are available. However, coaches, parents, and the junior member should give this decision great consideration, as the junior would then be subject to the same eligibility restrictions outlined below.

Only the team representing Colorado at the National 4-H Contest at Western Round-up is ineligible to compete at the Western National Round-up Contest again in the same contest/division. Members may continue to compete, as teams or individuals, in other national contests (such as those hosted by various breed associations etc.) so that they may further develop their skills.
